## Pricing

Dance (1 or 2 amateurs)

- \$50
- \$25 Youth(s) (12 yrs. and younger)

Formations (3 or more amateurs)

- \$20 each amateur dancer
- \$10 for each youth amateur dancer (12 yrs. and younger)

Performer Admission - **FREE**

Spectator Admission

- \$10 per USA Dance member (13+ yrs.)
- \$15 per non-USA Dance member (13+ yrs.)
- \$5 per child (4 to 12+ yrs.)
- FREE for children 3 yrs. and younger

**Late Entry Fees:** An additional \$10 per Dance, \$25 per Formation team for entries received after March 2<sup>nd</sup>. Late entries will be fit into the schedule at our discretion.

**Refund Policy:** A 100% refund if you cancel by March 2<sup>nd</sup>; a 50% refund up to March 16<sup>th</sup>. No refunds if cancelled on day of event. All cancellation notifications should be emailed to [info@usadancedenver.org](mailto:info@usadancedenver.org)

## Performance Timing

The maximum time allotted per entry is

- Dance = 2.5 minutes
- Formations = 4 minutes

## Music

**Provide music for your entries electronically (e.g., Dropbox or MP3 files) by Friday, March 2<sup>nd</sup>.** email to Michael Cushman ([mcushman@engagingchange.com](mailto:mcushman@engagingchange.com)). Make sure the files names consist of the performers' name and dance genre (ex: Betty Smith\_Joe Brown\_Tango) or the formation's name.
